Starting in the 2014-2015 academic year and continuing through the 2017-2018 academic year, we have frozen tuition rates.

On average, 80% of incoming classes receive scholarships. Such generous scholarship aid, together with the region's low cost of living, make Western New England University an excellent choice for a high quality, yet affordable, private legal education.
