

Coronavirus Response and Relieve Supplement Appropriations Act (CRRSAA) and American Rescue Plan Act (ARP) - Student Emergency Financial Aid Grants: Quarterly Report as of June 30, 2021

Western New England University signed and returned to the Department of Education the Certification and Agreement and we are providing assurance that we have used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) program to provide Emergency Financial Aid Grant to Students

The total amount of funds that Western New England University has received from the Department of Education and will receive is a total of \$4,824,900 pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students.

The total amount of Emergency Financial Aid Grants distributed to students under CRRSAA and ARP (a)(1) (a) (4) as of the date of submission for quarterly submission as of June 30, 2021 is **\$1,328,300**.

The estimated total number of students at Western New England University that are eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under CRRSAA and ARP (a)(1) (a)(4) is 4,177.

The total number of students who have received an Emergency Financial Aid Grant to students under CRRSAA as of June 30, 2021 is **1,264**. No funds were awarded to students under the APR program as of June 30, 2021.

The method used to determine which students receive Emergency Financial Aid Grants and how much they would receive under CRRSAA was a formulaic calculation. We have not made a determine how to award the ARP Emergency Financial Aid Grants yet.

Undergraduate students with an Expected Family Contribution (EFC) between \$0 - \$5,702 and were enrolled in at least 6 credits in both fall and spring semester in academic year 2020-2021 received \$1,500, if enrolled in one semester the award was \$750. Undergraduate students with an EFC between \$5,703 - \$9,999 and were enrolled for at least 6 credits in both fall or spring semester in academic year 2020-2021 received \$700, if enrolled in one semester the award was \$350.

Graduate students with an EFC of \$0 - \$9,999 and were enrolled for at least credits in two semesters in academic year 2020-2021 received \$700, if enrolled in one semester the award was \$350.

Student eligibility for purposes of the formulaic calculation was done prior to the Department of Education expanding eligibility.

The following is what we informed our students via email who received an award:

You have been awarded a **Higher Education Emergency Relief Fund (HEERF II) student grant** provided by the CRRSAA, Consolidated Appropriations Act, 2021.
