

# Coronavirus Response and Relieve Supplement Appropriations Act (CRRSAA) and American Rescue Plan Act (ARP) - Student Emergency Financial Aid Grants: Quarterly Report as of March 31, 2022

## FINAL STUDENT REPORT

### (Report Revised December 9, 2022)

*The March 31, 2022 Student Emergency Financial Aid quarterly report is being revised to: correct the original figures reported for total students eligible to receive Emergency Financial Aid Grants to students under CRRSAA and ARP; the total amount of Emergency Financial Aid distributed to students; and the total number of students who received an Emergency Financial Aid Grant under CRRSAA and ARP as of March 31, 2022. All figures have been changed to reflect quarterly totals vs. cumulative CRRSAA and ARP totals. The total number of eligible students was originally reported as 4,177 (CRRSAA) and 5,928 (ARP). The total amount of Emergency Financial Aid distributed to students was originally reported as \$4,824,900. The total number of students who received an Emergency Financial Aid Grant was originally reported as 3,559. No other changes were made to the original March 31, 2022 student aid report dated April 10, 2022.*

Western New England University signed and returned to the Department of Education the Certification and Agreement and we are providing assurance that we have used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) program to provide Emergency Financial Aid Grant to Students.

The total amount of funds that Western New England University has received from the Department of Education and will receive is a total of \$4,824,900 pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students.

The total amount of Emergency Financial Aid Grants distributed to students under CRRSAA and ARP (a)(1) (a) (4) for the quarter covering the period January 1, 2022 through March 31, 2022 is **\$12,602**.

The estimated total number of students at Western New England University that were eligible to participate and receive Emergency Financial Aid Grants under CRRSAA and ARP (a)(1) (a)(4) during the quarter covering the period January 1, 2022 through March 31, 2022 is **3,660**.

The total number of students who have received an Emergency Financial Aid Grant under CRRSAA and ARP during the quarter covering the period January 1, 2022 through March 31, 2022 is **25**. In addition, there were **15** students who had their Emergency Financial Aid Grants awarded during a previous quarter, voided during the current quarter due to their checks remaining uncashed after all reasonable efforts were exhausted to contact these students. The result is that **10** net new students received Emergency Financial Aid Grants during the quarter ended March 31, 2022.

### CRRSAA

The method used to determine which students receive Emergency Financial Aid Grants and how much they would receive under CRRSAA was a formulaic calculation.

Undergraduate students with an Expected Family Contribution (EFC) between \$0 - \$5,702 and were enrolled in at least 6 credits in both fall and spring semester in academic year 2020-2021 received \$1,500, if enrolled in one semester the award was \$750. Undergraduate students with an EFC between \$5,703 - \$9,999 and were enrolled for at least 6 credits in both fall or spring semester in academic year 2020-2021 received \$700, if enrolled in one semester the award was \$350.

Graduate students with an EFC of \$0 - \$9,999 and were enrolled for at least 6 credits in two semesters in academic year 2020-2021 received \$700, if enrolled in one semester the award was \$350.

Student eligibility for purposes of the formulaic calculation was done prior to the Department of Education expanding eligibility. For the remainder of CRRSAA funds available, after the allocation using the formulaic method, we have awarded funds to eligible students who have informed the University of their extenuating and excessive financial hardship.

The following is what we informed our students via email who received a CRRSAA award:

You have been awarded a **Higher Education Emergency Relief Fund (HEERF II) student grant** provided by the CRRSAA, Consolidated Appropriations Act, 2021. ### **ARP**

The methods used to determine which students receive Emergency Financial Aid Grants and how much they would receive under ARP were a formulaic calculation and an application process.

**Formulaic calculation:** The awards using the formulaic calculations were based on a combination of factors that include financial criteria (Expected Family Contribution as determined by the FAFSA, financial hold and outstanding balance indicators), academic level, cumulative grade point average, class level, first-generation college status, enrollment status as well as additional weighting for students ineligible to file a FAFSA and reduced weighting for students who receive tuition remission or tuition exchange support or who are part of a direct billing program for their tuition charges.

The following is what we informed our students via email who received an ARP formulaic award:

**You have been awarded a Higher Education Emergency Relief Fund (HEERF III) student grant.** These funds are part of the American Rescue Plan which provides support to institutions of higher education to ensure learning continues during the COVID-19 pandemic.

Your grant does not need to be repaid. You can view the amount of the grant online via your [Financial Aid Self-Service](#) page. Select the *My Awards* tab for the 2021/2022 Academic Year.

HEERF III checks will be available for pick-up at the bank in Enrollment Services between the hours of 8:30am-4:30pm, Monday through Friday. Please bring a valid photo ID. **New student awards are subject to confirmation of enrollment.** Checks are available as follows:

- *Continuing students starting Friday, September 3*
- *New students starting Thursday, September 23*

**Application process:** The application process was for currently enrolled students who experienced financial hardship related to any component of the student's cost of attendance or for emergency costs that arose due to coronavirus, such as tuition, food, housing, health care (including mental health care) or childcare. Students who were currently enrolled in a degree program at Western New England University were eligible for the application process.
