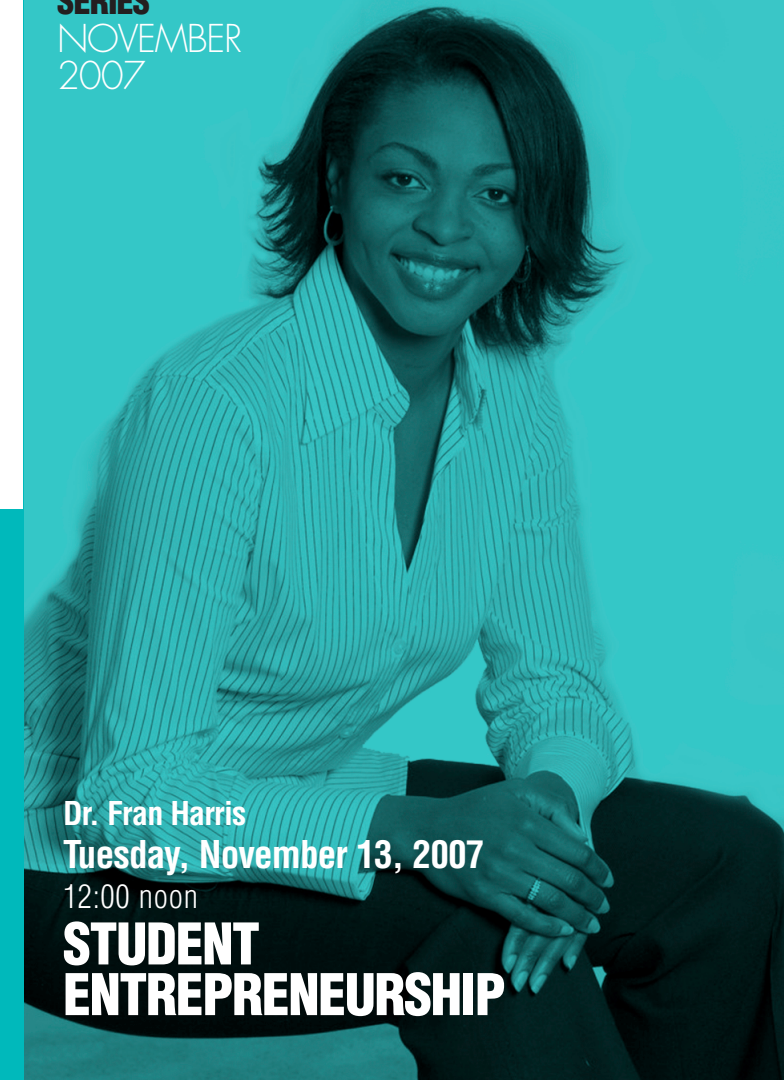

Dr. Harris has traveled to over 30 countries worldwide on the inspirational speaker circuit. She addresses corporations, universities, entrepreneurs, women's events, and business conferences and speaks to over 100,000 people yearly. She is also a noted business strategist, consulting Fortune 100 companies and emerging entrepreneurs alike. Two years ago she created the 100 Women Millionaires Challenge, a unique business and wealth coaching program. Dr. Harris is currently in postproduction on a documentary on poet Nikki Giovanni and she is shopping a syndicated talk show starring herself to distributors.
